- 1. Value of the scholarship will be Rs. 58,479/- per recipient for the academic year.
- 2. Duration of the scholarship will be one year commencing from 30th September 2022 till 29th September 2023 and scholarship may/may not be extended for another year.
- 3. Eligibility Criteria
 - I. Students who have registered at;
 - Faculty of Management and Finance, University of Colombo
 - Faculty of Management Studies and Commerce, University of Sri Jayewardenepura

and;

- Students who are not receiving any financial assistance from University or any other organization by way of Mahapola, Bursary or any other scholarships etc.
- 4. Students will be selected on the performance at the G.C.E. (Advanced Level) examination, parental income and other factors as decided by the Selection Committee.
- 5. The decision of the selection panel will be the final and no further correspondence will be entertained.
- 6. Specimen Application is available at the Dean's office of the relevant Faculty, student welfare branch of the University and UGC website (www.ugc.ac.lk).
- 7. Closing date of the applications is 10th December 2022

- All questions included in the application should be read carefully and answered in full.
- You should attach an income Assessment Report issued by the Divisional Secretariat of your area to prove the income from estates, fields, lands etc. and income from houses rented or leased.
- Salary particulars including all allowances regarding the Gross Annual Income of your father/ mother from the occupation pension certified by the respective employer (Original) should be attached. If your father/ mother is an entrepreneur/ selfemployed, an Income Assessment Report certified by the Divisional Secretariat should be attached. (Period of 12 months from January 2021 to December 2021).
- If your father's mother's service has been terminated or he/ she has retired during the income assessment period (i.e. from January 2021 to December 2021) you should clearly state such period and attach certified copies of documents (pension award letter or employment termination letter) issued by the relevant authorities.
- Particulars regarding sources of income and all other information should be stated in full. Particulars of income furnished by you, will be checked with relevant Grama Niladhari officers and the Divisional Secretariat.
- If you have any school attending brothers or sisters who are 19 years or below, you should attached the certified copies of the birth certificate of them.
- Part A, B & C should be dully filled by the applicant and handed over to the Registrar of the particular University in order to complete Part D.
- Incomplete applications will be rejected and copy of the <u>National Identity card</u> should be attached.
- The closing date of applications is **10**th **December 2022**
